<b>8/17/2022</b> E – 83	<b>Impartial and Fiscal Analyses Deadline</b> Impartial Analysis and Fiscal Impact Statement (if applicable) due from County Counsel for school and county measures or from City Attorney for city measures. <b>8/17 – 8/27</b> E- 83 – E- 73	<b>10-Calendar Day Public Review Period for Impartial Analysis</b> During this 10-Calendar day review period, any person may seek Writ of Mandate or injunction requiring any or all of the material in the Impartial Analysis to be amended or deleted. All Writs of Mandate must be filed by the end of the 10-Calendar day public examination period.	EC §§ 9190, 9295,9380, 9509

<b>8/22 – 9/01</b> E- 78 – E- 68	<b>10-Calendar Day Public Review Period for Direct Arguments</b> During this 10-Calendar day review period, any person may seek Writ of Mandate or injunction requiring any or all of the material in the Argument IN FAVOR OF or AGAINST to be amended or deleted. <b>8/30/2022</b> E – 70	<b>Board of Supervisors Meeting</b> Meeting with the Board of Supervisors to approve or deny the request for consolidation of a local measure with the election.

**IMPORTANT NOTE FOR CITIES:** Cities are responsible for the publication of the "Notice of Election" for their measures and the publication of the "Notice to Submit Arguments"; the receiving and processing of direct arguments/rebuttal arguments; and the preparation of the Impartial Analysis. Due to cities consolidating with the county under EC § 10400, the above dates will be used for deadlines regarding arguments, rebuttals and the 10-day public viewing periods.
