## Unsigned Ballot Statement

READ THESE INSTRUCTIONS CAREFULLY.

**FAILURE TO FOLLOW THESE INSTRUCTIONS MAY CAUSE YOUR VOTE-BY-MAIL BALLOT NOT TO COUNT.**

1. You did not sign your vote-by-mail or provisional ballot identification envelope. In order to ensure that your vote-by-mail or provisional ballot will be counted, your Unsigned Ballot Statement should be completed and returned as soon as possible so that it can reach our office **no later than 5:00 p.m. two days prior to the certification of the election.**
2. You must sign your name below where specified on the Unsigned Ballot Statement (Voter's Signature) and include your complete residence address.
3. The completed Unsigned Ballot Statement may be mailed or delivered to:  
Yolo County Elections, 625 Court Street, Suite B-05, Woodland, CA 95695  
Be sure there is sufficient postage if mailed and that the address of our office is correct. **Postmarks will not count.**
4. Or the completed Unsigned Ballot Statement may be emailed to Elections@yolocounty.org, faxed to (530) 666-8123 or submitted to a voting location within the county or a county ballot drop box before the close of the polls on Election Day.
5. Please note that the signature provided on the completed Signature Verification Statement may be added to your registration record to be used for signature comparison purposes in future elections.

### UNSIGNED BALLOT STATEMENT

I declare under penalty of perjury that I requested and returned a vote-by-mail or provisional ballot and that I have not and will not vote more than one ballot in this election. I understand that if I commit or attempt any fraud in connection with voting, or if I aid or abet fraud or attempt to aid or abet fraud in connection with voting, I may be convicted of a felony punishable by imprisonment for 16 months or two or three years.

I understand that my failure to sign this Statement means that my vote-by-mail or provisional ballot will be invalidated.
