- You did not sign your vote-by-mail or conditional/provisional ballot identification envelope. To ensure that your vote-by-mail or conditional/provisional ballot is counted, your Unsigned Identification Envelope Statement must be completed and returned as soon as possible and <u>received no later than 5:00 p.m. two days prior to the certification of the election.</u> Please contact the Elections Office at (530) 666-8133 or <u>elections@yolocounty.org</u> for the exact date.

- 3. You must sign the form (your signature or a witnessed "mark") and include your complete residence address.
- 4. Your completed Unsigned Identification Envelope Statement may be returned by:

 use the postage paid return envelope provided by the Yolo County Elections Office or, if using your own
 envelope, be sure there is sufficient postage and that the address of our office is correct. Postmarks will not
 count.

 - Hand-delivered to an open voting location within the county or a county ballot drop box before the close of the polls on Election Day.
- 5. Please note that the signature provided on the completed Unsigned Identification Envelope Statement may be added to your registration record to be used for signature comparison purposes in future elections.

UNSIGNED IDENTIFICATION ENVELOPE STATEMENT (please print full name as registered to vote), am a registered voter of **YOLO** County, State of California. I declare under penalty of perjury that I requested (or I received) and returned a vote-by-mail or conditional/provisional ballot and that I have not and will not vote more than one ballot in this election. I am a resident of the precinct in which I have voted, and I am the person whose name appears on the vote-by-mail or conditional/provisional ballot envelope. I understand that if I commit or attempt any fraud in connection with voting, or if I aid or abet fraud or attempt to aid or abet fraud in connection with voting, I may be convicted of a felony punishable by imprisonment for 16 months or two or three years. I understand that my failure to sign this Statement means that my vote-by-mail or conditional/provisional ballot will be invalidated.
